

Privacy Policy

- This privacy policy is governed by and interpreted according to English law. All disputes arising under this privacy policy are subject to the exclusive jurisdiction of the English courts.

How we collect your information:

- When you provide it to us by contacting us, requesting a brochure or information via our website.
- From using our website cookies.

Personal information we collect:

- Name, contact details, including telephone number and email address.
- When browsing our website this may include your IP address, location, browser type and operating system, referral source, page views and navigation paths through our website.

How we use your personal data:

- We use your data so that we can contact you with any further information, to improve our services and website through analysis, and for advertising purposes.
- Whenever you are required to submit data, you have the right to withold the use of this data. This can include:
 - Use of your data for marketing purposes.

How we secure your personal data:
